APPROVAL IS CONTINGENT UPON ADHERENCE TO THE FOLLOWING CONDITIONS IN ACCORDANCE WITH THE NEW JERSEY UNIFORM FIRE CODE, N.J.A.C. 5:70-3,307 :

- ◆ *Bonfire shall be no more than 5 ft x 5ft x 5ft in diameter and shall burn no longer than 3 hours*
- ◆ *Bonfire shall not be less than 50 feet from any structure and provisions shall be made to prevent the fire from spreading to within 50 feet of any structure.*
- ◆ *Materials used to fuel the bonfire shall consist only of seasoned dry firewood and shall be ignited with a small amount of paper. The fire shall not be used for waste disposal purposes, shall be of minimum size for the intended purpose and the fuel shall be chosen to minimize the generation and emission of air contaminants.*
- ◆ *Open burning, bonfires or recreational fires shall be constantly attended until the fire is extinguished. A minimum of one portable fire extinguisher with a minimum 4-A rating or other approved on-site fire-extinguish equipment, such as dirt, sand, water barrel, garden hose or water truck, shall be available for immediate utilization.*

THE FIRE CODE OFFICIAL IS AUTHORIZED TO ORDER THE EXTINGUISHMENT BY THE PERMIT HOLDER, ANOTHER PERSON RESPONSIBLE OR THE FIRE DEPARTMENT OF OPEN BURNING THAT CREATES OR ADDS TO A HAZARDOUS OR OBJECTIONABLE SITUATION.
