Michael Castore, Esq., introduced himself as the Attorney on Behalf of the Applicant. He briefly described the Application and the subject property located at 3545 Shafto Road.

Mr. Castore called Mr. Boesch as the first witness this evening.

Mr. Boesch placed his credentials on the record and the Board accepted him as an expert witness in the field of Landscape Architecture.

Attorney Collins noted for the record that the Board reviewed this same exact application in 2019. However, the Applicant did not perfect the Subdivision within the required time frame, therefore, his approvals expired, and he had to reapply for Minor Subdivision approval.

Ms. Beahm noted that the only variance the Applicant is seeking this evening is for the minimum lot width of lot 5.011. 200 feet is required by Ordinance whereas 198.60 is proposed. She asked Mr. Boesch to confirm that the plans before the Board this evening are the same as what was approved in 2019, and he confirmed that no changes have been made. Ms. Beahm stated that she takes no exception to the requested variance relief.

Attorney Collins explained that at one point in time the Applicant was proposing a three-lot subdivision, and at the recommendation of the Board, revised the plans to a two-lot Minor Subdivision.

Mr. Castore added that he was not involved with the previous application submission, but assured the Board that he will ensure that all approvals are finalized within a timely manner. The Minor Subdivision will be filed be Deed. Mr. Neff requested that any Deeds and Easements be sent to T&M Associates for review. The Applicant agreed to comply with any outstanding comments in both T&M & Avakian Review Letters.

Ms. Beahm and Mr. Neff stated that they have no objections to the application.

Seeing no members of the public present, Chairman Lodato asked for a motion to close the Public Discussion.

Mr. Clayton offered a motion to close the Public Discussion, the motion was seconded by Mr. Natter. All present voted in favor.

Mr. Clayton offered a motion to approve PB2023-09 with the conditions set forth by Attorney Collins. The motion was seconded by Mr. McCoy.
